HALL/GROUNDS- Refrigerator overheated, on election, day, has been replaced. Kitchen faucets are leaking, will replace them next. Range also needs to be replaced, as it does not heat correctly.

CEMETERIES- Towns needs a new rope on the flagpole, ASAP, frayed. J. Gallie found three grave sites that needed veteran markers and flags, he has completed, as well as continuing to map grave sites, and cleaned garbage and old flowers. Two exit signs need to be ordered.
