ELECTIONS- November 2, 2021, special election is for a road millage for Amber Township. We are the only election in the County. The VAT and ballots were tested 48 days before the election by Clerk Rohde and her Deputy Clerk. The next Election Commission meeting is Monday, October 4 at 10 a.m. to approve inspectors. The Tabulator testing is Wednesday, October 20, 2021 at 9 a.m. at our hall. Absentee ballots applications sent out-442, 114 returned to date/114 ballots mailed out, 21 which have been returned.

HALL/GROUNDS- Have a call in to plumber to check/repair the urinal.

CEMETERIES- Rickey: Received a bid for \$1790 from Mac's Tree Service for tree cutting and removal from the storm, needs to be done ASAP due to scheduled funerals. Bill will be submitted to our Insurance company as a claim for storm damage.
